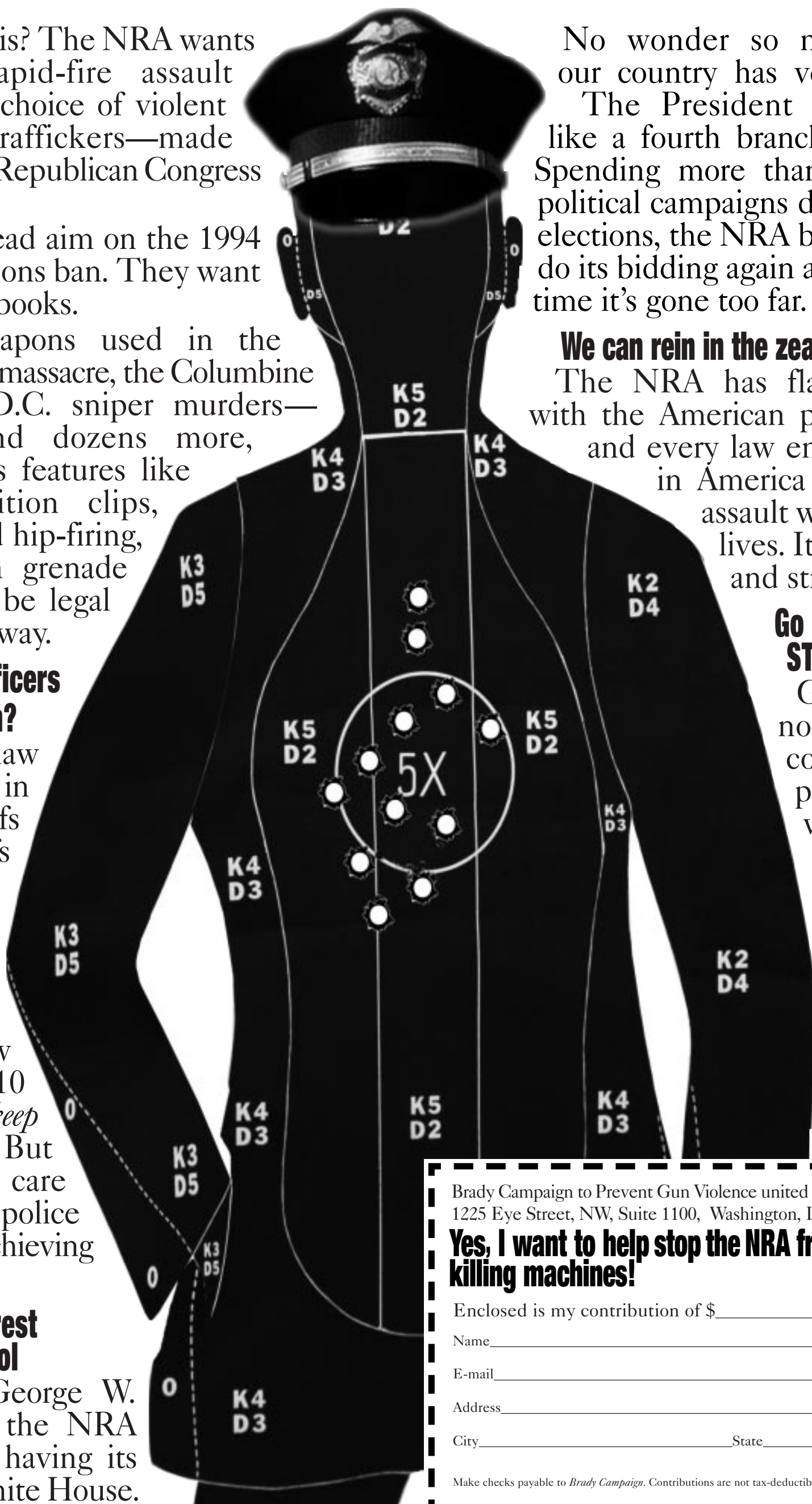
Haven't our police officers sacrificed enough?
